

Anti-Doping Annual Review 2020-2021

Education & capacity building

- Educators 2020/2021 has seen a change of personnel within the performance set up and therefore a change in the number of Educators. Two new Educators have received UKAD training, increasing the number of Educators in the Performance department to five (two sit within GB EDP and three sit within U16 & U18 squads). The Ethics and Welfare Team now has three Educators meaning there are now 8 UKAD accredited Educators within England and Great Britain Hockey. One external Educator remains involved within U16 & U18 squads / DiSE delivery.
- England and Great Britain Hockey Educators have accessed virtual UKAD Forums throughout the year.
- New Staff Clean Sport inductions are given to all new staff and made relevant to their role.

Senior squads (Elite)

- Senior squad athletes attended Tokyo 'Clean Sport' Workshops (Longlisted athletes) on 10th February 2021 (Men's Squad 1 athlete) and 12th February 2021 (Women's Squad 1 athlete) and 'Clean Games' Workshops on 16th June 2021 (Men's Squad 19 athletes plus 14 ASP) and 22nd June 2021 (Women's Squad 20 athletes plus 3 ASP). Two mop up 'Clean Games' workshop were delivered following this on 30th June 2021 (Men's Squad 1 athlete) and 21st July 2021 (1 ASP).
- Education delivered in line with Clean Games Policy for Tokyo 2020.
- All ASP completed either 'Coach Clean' or 'Advisor' as required as part of the UKAD / BOA Clean Games Policy.
- 'Induction' education sessions delivered to athletes joining the full-time programme.
- Requested registers confirming education were issued to the FIH. Copies of attendance registers shared with UKAD as requested.

GB Elite Development Pathway (EDP)

• EDP athletes longlisted for Tokyo attended virtual 'Clean Sport' education on 3rd February 2021 (7 athletes), 8th February 2021 (4 athletes), 10th February 2021 (3 athletes) and 12th February 2021 (3 athletes). Further to this, EDP athletes attended virtual 'Clean Sport' education on 1st July 2021 (EDP Men – 15 athletes, EDP Women

- 7 athletes) and 12th July 2021 (EDP Men − 19 athletes, EDP Women − 10 athletes).
- EH have maintained and monitored records and registers of attendance at clean sport sessions.

Club Education (Premier Division)

 All 20 (10 male, 10 female) clubs were contacted, confirming points of contact. All clubs were offered free, virtual clean sport education delivered by EH Educators. No clubs took up this offer during the 2020-2021 season.

England Age Groups

- U16 Girls EH Educators delivered to 46 athletes plus 5 ASP on 14th February 2021
- U16 Boys EH Educators delivered to 33 athletes plus 3 ASP on 14th February 2021
- U18 Girls EH Educators delivered to 60 athletes on 14th February 2021
- U18 Boys EH Educators delivered to 58 athletes on 14th February 2021
- EH have maintained and monitored records and registers of attendance at Clean Sport sessions.

Diploma in Sporting Excellence (DiSE)

- EH Educators delivered to 54 girls and 56 boys on 15th February 2021
- EH have maintained and monitored records and registers of attendance at Clean Sport sessions.

Athlete Support

- Testing EH continue to monitor the number of tests occurring at elite and club level with 27 GB athletes tested by UKAD during 2020-2021.
- Quarterly Whereabouts was submitted to UKAD and FIH by EH's Performance Officer on behalf of senior squads.

Misc.

- EH are actively working towards compliance with UKAD's Assurance Framework
- EH website updated to reflect updated World Anti-Doping Agency (WADA) 2021 Prohibited List and other relevant key messages.
- EH distributed information relating to the changes in the 2021 WADA Code to the relevant parties.
- ENG/GB Hockey Educators have attended virtual forums delivered by UKAD, including Clean Sport Live webinars, Clean Sport @ the Front Line, Clean Sport Forum and other appropriate forums/webinars.
- UKAD key messages shared with athletes and ASP, particularly around changes to the prohibited list, information on CBD oil, emergency medicines and hay fever.



- Continued discussions on development of a Substances of Abuse policy/stance.
- Discussions on clarity of responsibility for education of GB athletes when they are training/playing for Home Countries.
